("Clare Controls"), 7519 Pennsylvania Avenue Sarasota, Florida USA, warrants to the original retail purchaser that original Clare Controls products and components (the "Product") will be free from defects in materials and workmanship for a period of three (3) years from the date of shipment from Clare Controls (the "Warranty Period"). If the Product fails to conform to this Limited Warranty during the Warranty Period, Clare Controls will, at its sole discretion and election, either (a) repair or replace any defective Product or component; or (b) accept the return of the Product and refund the money actually paid by the original purchaser for the Product. Repair or replacement may be made with a new or refurbished product or components, at Clare Controls' sole discretion. If the Product or a component incorporated within it is no longer available. Clare Controls may, at Clare Controls' sole discretion, replace the Product with a similar product of similar function. This is your sole and exclusive remedy for breach of this Limited Warranty. Any Product that has either been repaired or replaced under this Limited Warranty will be covered by the terms of this Limited Warranty for the longer of (a) ninety (90) days from the date of delivery of the repaired Product or replacement Product, or (b) the remaining Warranty Period. This Limited Warranty is not transferable from the original purchaser to subsequent owners.

## 2. WARRANTY CONDITIONS.

Before making a claim under this Limited Warranty, the original purchaser of the Product must (a) notify Clare Controls of the intention to claim by visiting www.clarecontrols.com/returns during the Warranty Period and providing a detailed description of the alleged failure and all third-party Product Peripherals defined below), and (b) comply with Clare Controls' return merchandise authorization policy (the "RMA Policy"; www.clarecontrols.com/returns) and return shipping instructions. Clare Controls will have no warranty obligations with respect to a Product if it determines, in its reasonable

discretion after examination of the Product, that the Product is an Ineligible Product (defined below). Clare Controls will bear costs of return shipping to the original purchaser, except with respect to any Ineligible Product, for which the original purchaser will bear all shipping costs.
