Does My Snap AV Credit Card Information Transfer to Allnet?

No, banking laws prevent the transfer of credit card information in this manner. You will need to enter your credit card information on the Allnet partnership agreement before you can place your first order.

Do Purchases at Allnet Count Toward the SnapAV Partner Rewards Program?

Yes. Purchases of SnapAV product and eligible third-party products will count toward the annual spend requirements for the SnapAV Partner Rewards Program. Spend on SnapAV-manufactured products will also count toward your quarterly rebate. You should continue to check your Rewards Program status on the SnapAV website.
